

# **Domestic Regulations S.K.V. Hercules**

## **Huishoudelijk reglement vertaald naar Engels.**

### **Article 1: The association**

- a. The association has the name Studenten Krachtsport Vereniging HERCULES (translated: student strength-sport association), afterwards to be named: the association. The association is founded on January 16 2002, located in Enschede, The Netherlands.
- b. The goals and purposes of the association can be found in article 2 of the official statutes of the association.
- c. The financial year starts on the first of September till the last day of August.
- d. The association consists of members.
- e. The association uses the fitness/ strength-sport facilities of the University of Twente and CrossFit Twente.

### **Article 2: Obligations of members**

- a. The members needs to have a facility card, which is issued by the Student Union University Of Twente, which is described in the facility cards section of the Student Union. This can consist of the Union Card or the Campus Card.
- b. When using the sport facilities, each member has to wear sports clothing and clean shoes, and has to use a towel when using equipment.
- c. Within one month of the new academic year, members have to pay their membership fee. New members have to pay the membership fee at the start of their membership.
- d. If a member wants to cancel, he must notify the secretary in writing or by email at least one month before the end of the association year.
- e. Any defects found in equipment of the facilities, must be reported immediately to the Hercules board, CrossFit Twente or the Sports Centre.
- f. A member must pay the imposed fines within 14 days after the receipt of the receipt.

### **Article 3: Member's rights**

- a. Use of the equipment made available by the association.
- b. Participation in the activities organized by the association.
- c. Attending the general members assembly.
- d. Occupy board- and committee functions.

### **Article 4: Fines**

- a. Fines that are issued on the association by a third party, because of a member failing to fulfil one or more obligations, as described in article 2, should be paid by the concerned member.
- b. If a member is too late with cancelling their membership, as described in article 2d, before the start of the new association year, this member should pay a fine of 10 euros to the association for administration costs.

**Article 5: Financial committee**

- a. The financial committee is yearly selected by the general assembly.
- b. The financial committee checks the finances of the association at least once a year.
- c. The financial committee can perform inspection of the finances as they see fit to give advice in financial matters.
- d. The financial committee reports on every financial overview. After acceptance of the general assembly the treasurer is discharged of this part of their function.
- e. It is not possible to be on the board and on the financial committee at the same time.
- f. The members of the financial committee can be renamed immediately.

**Article 6: closing statements**

- a. The statutes and further rules and regulations can be obtained from each board member for inspection.
- b. When the regulations do not suffice or in case of doubt, the board decides.
- c. Regulations in the domestic regulations that are in dispute with the statutes are invalid.
- d. Every member has to know the regulations of the statutes, domestic regulations and rules and regulations decided on by the board or general assembly.
- e. The association is not responsible for injuries, illness, accidents or damage by/to its members.
